**Call to Order:** President Debbie Binkley called the meeting to order at 10:00 a.m. She introduced our guest speaker, Chief Jeffrey Van Slyke, with the University Police Department. Also, attending from UPD were Terri Kitchens and Linda Christian. Chief Van Slyke addressed a letter which had been submitted by the Staff Council in regards to the cost of parking decals when both husband and wife work on campus. He was not aware that employees were being charged \$120.00 for both to obtain decals. He assured the staff that he was having Terri Kitchens check the database for parking services to ensure all employees who paid the \$120.00 amount were credited back the additional \$50.00. The rate should have been \$60.00 for the first decal and \$10.00 for the second.

The matter of campus safety was another topic of discussion for Chief Van Slyke in which he assured the group “our campus was no less safe than Wal-Mart”. His suggestions were that everyone had to be aware of their surroundings. The matter of the issues surrounding the recent assaults on campus were touched on explaining the warnings are being sent out by email to assist in helping the UPD with catching predators. This method of submitting warnings in a timely manner helps to heighten awareness and can prove valuable in putting an end to situations.

Ron Kitchens asked if Parking Services had received a lot of complaints since Meek Hall parking lot and the lot behind the Union had been changed to staff parking. Linda Christian stated they had not received a lot of complaints. Julie Baker praised the UPD staff for the recent text message which was sent out in regards to the murder of the Ole Miss student. The UPD also offers a Rebel Patrol program that will provide an escort to and from your vehicle when working late on campus.
