- a) The Executive Board met with the Chancellor. The following was discussed and a letter will be sent out from the Chancellor informing the staff of the discussions.
 - Desire to increase enrollment with current resources
 - Sincerely hopeful of no job cuts
 - Possible restructure, staff might be moved around to cut down on job losses if cuts are necessary
 - We need to work to maintain the image of being the hardest working university in the state
 - Unable to make changes to state benefits

- Cannot make changes to Parking as it would take away revenue from school that is desperately needed
- Cannot close for spring break. The University would only save money if everyone took week without pay.
- We are in a three year recession and the University faces eventual budget cuts totaling \$20 million
- Desire to keep lines of communication open between the staff and Chancellor
- b) Fundraising Committee Report The committee met to discuss fundraising and it was decided to keep the Adopt a Basket program and car wash. Other ways we could raise money that were discussed were the possibility of an ice cream social, raffle, silent auction, and participation in local charities
- c) Website Development The executive board met with Stephanie Mitchell on the progress of updating the website. The following was discussed:
 - Stephanie asked that the Staff Council check the site for accuracy. The new site will be available soon
 - A survey for communication from staff to Staff Council will be added to the site
 - Site will reflect a current featured department or staff member

 - g) Shelia Goolsby announced the Oxford Alzheimer's Memory Walk will be held on October 31, 2009. It is Oxford's first annual Memory Walk. It will be from the Lyceum to the Museum.
 - h) Outstanding Staff Member for September the outstanding staff member for September is Robert Sisk, he is on the janitorial staff in Martindale and he will be given a certificate for this honor.
